

FACTS**WHAT DOES Blend Insurance Agency
DO WITH YOUR PERSONAL INFORMATION?****Why?**

Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.

What?

The types of personal information we collect and share depend on the product or service you have with us. This information can include:

- Social Security number and Transaction or loss history
- Risk tolerance and Insurance claim history
- Checking account information

When you are *no longer* our customer, we continue to share your information as described in this notice.

How?

All financial companies need to share clients' personal information to run their everyday business. In the section below, we list the reasons financial companies can share their clients' personal information; the reasons Blend Insurance Agency chooses to share; and whether you can limit this sharing.

What we do

How does Blend Insurance Agency protect my personal information?

To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings.

Access to your personal information is restricted to our employees and other who we feel must use it to provide our products and services.

How does Blend Insurance Agency collect my personal information?

We collect your personal information, for example, when you

- Open an account or Apply for insurance
- Give us your contact information or Pay insurance premiums
- File an insurance claim

We also collect your personal information from affiliates and other companies.

Why can't I limit all sharing?

Federal law gives you the right to limit only

- sharing for affiliates' everyday business purposes—information about your creditworthiness
- affiliates from using your information to market to you
- sharing for nonaffiliates to market to you

State laws and individual companies may give you additional rights to limit sharing. **See below for more on your rights under state law.**

Definitions

Affiliates

Companies related by common ownership or control. They can be financial and nonfinancial companies.

- *Our affiliates include financial companies such as Blend Title Insurance Agency, Inc. and nonfinancial companies, such as Blend Labs, Inc., and Blend Brokerage DBA, Blend Realty, Inc.*

Nonaffiliates

Companies not related by common ownership or control. They can be financial and nonfinancial companies.

- *Blend Insurance Agency does not share with nonaffiliates so they can market to you.*

Joint marketing

A formal agreement between nonaffiliated financial companies that together market financial products or services to you.

- *Blend Insurance Agency may enter into agreements with other insurance agencies to jointly offer products and services to you.*

Other important information

Vermont

We will not disclose information about your creditworthiness to our affiliates and will not disclose your personal information, financial information, credit report, or health information to nonaffiliated third parties to market to you, other than as permitted by Vermont law, unless you authorize us to make those disclosures.

Other important information (continued)

California

In accordance with California law, we will not share information we collect about you with non-affiliated third parties, except as permitted by law, including, for example, with your consent or to service your account. We will limit sharing among our affiliates to the extent required by California law.
